Toddle is a comprehensive teaching and learning platform used by thousands of schools around the world. It helps schools streamline lesson planning, assessments, progress tracking, and home-school communication.

How will your child use Toddle?

- **Lesson plans** - Your child will be able to view the lesson plans and assessments that teachers create on Toddle.
- **Classroom submissions** – All student work will be uploaded to Toddle, where teachers will review, assess, and share feedback.
- **Portfolios** – Your child can document their learning journey by adding photos, videos, notes, and worksheets to their personal portfolio on Toddle.
- **Academic reports** – Reports on your child's progress will be created and shared via Toddle.

Privacy and Data Protection

To function effectively, Toddle collects limited personal information (e.g., a child's name or school email address). This information is never sold, shared, or used by Toddle for any purpose beyond providing educational services.

Toddle has been assessed by Safer Technologies 4 Schools (ST4S), and complies with major global privacy regulations, including the Australian Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs), ensuring that student data is handled securely and responsibly. Additionally, Toddle meets internationally recognised security standards, including: ISO/IEC 27001:2022, ISO/IEC 27017:2015, ISO/IEC 27018:2019, and ISO/IEC 27701:2019—and has successfully completed a SOC 2 Type II audit, reflecting a strict control environment for data security, availability, and confidentiality.

All personal data is encrypted both in transit and at rest and securely stored on Amazon Web Services (AWS) servers.
